reflects the successful course of business.

By leveraging initial synergies following the merger of STARCAR and EUROPA SERVICE, rental revenue from the operating divisions was increased by around €10 million to €126,111,486,95.

Despite substantial investments, such as in IT infrastructure, digitisation and expansion for the purpose of post-merger integration of the companies and further scaling, the Group again generated a pre-income-tax profit of

€5,599,315.26

in 2019. The Group is therefore expanding on healthy foundations to realise its goals and overarching vision.
